Please carefully review this bridal contract, complete and submit both pages of this agreement with a non-refundable, non-transferable retainer fee of \$300 to confirm, secure and hold that special day just for YOU in 2018. This \$300 is put towards the remaining balance on the day of the event and the complete balance for your wedding party will be due 7 days before your wedding day.

### THE DEETS

A minimum total of \$350 in combined styling and/or glammed fees is needed to secure onsite, "the big day" needs. When travelling to you and your girls, I will include 80 km of travel time and fuel. Any additional travelling time/km will be charged at .45c/km and \$20/hr. The bride will agree to cover any additional parking costs incurred. The bride agrees that all information, timing, location and amount of ladies to be styled will be confirmed no later than the bridal trial, and the amount of ladies confirmed will be the amount paid for. The bride will agree to schedule a trial hair and/or makeup in my home salon (recommended) 4-6 weeks prior to the big day. All listed pricing includes the 13% HST tax. Gratuity is not included in the listed pricing - if you feel I added an extra special touch to your big day, please feel free to add gratuity at your discretion prior to or the day of.
